STANDARDISED AND CUSTOM-MADE KITS



Kits help create standardisation in healthcare delivery, resulting in efficient packing and delivery of medicines and medical goods. IDA supplies standardised and custom-made kits to help our customers quickly set up and roll out their emergency response or to execute health specific projects.

The following kits offered by IDA are designed according to WHO requirements (cholera, paediatric and measles kits) and UN and humanitarian agencies requirements (IEHK).

All kits follow a modular set-up and can be ordered as a kit or as separate modules.

INTERAGENCY EMERGENCY HEALTH KIT 2024

The Interagency Emergency Health Kit (IEHK) 2024 is primarily intended for displaced populations affected by emergencies, who have limited access to routine health care services.

A complete emergency health kit contains 10 basic units and one of all supplementary units, and includes medicines, disposables, and instruments to meet the needs of 10.000 people for three months.



The full kit or kit modules can also be used for the initial supply of primary health care facilities where the normal system of provision is interrupted. However, it is not intended as re-supply or to replace existing medical supply chain mechanisms, as this may result in access stock of items or medicines which are not needed.

CHOLERA KITS 2020

The cholera kits are designed to support the first month of the initial response to an outbreak. Each type of kit (treatment of 100 cases) has been adapted to the specific use and needs required in various health settings during an outbreak i.e., central, peripheral and community level.

PAEDIATRIC KIT INCLUDING SAM/MC CHILDREN 2020

The PED/SAM kit is specifically designed for children and provides suitable medicines, renewables, and equipment to treat common childhood illnesses including severe acute malnutrition (SAM) with medical complications (MC). One kit can treat 50 children with severe acute malnutrition and medical complications. The kit can also be used in paediatric wards (10-15 beds) for 3 months.

The measles kit 2021 is specifically designed to prepare for and support the treatment of associated complications in non-severe and severe cases during a measles outbreak. The kit modules contain essential medicines, supplies and equipment for the management of clinical suspected and severe measles cases.

KITTING AND WAREHOUSING IN DUBAI

The composition and logistics of kits can be complex. Therefore, IDA's kitting facility is strategically located in Dubai close to both airport and seaport - at the cross-road between Asia, Africa, and Europe - connecting the supply chain consisting of manufacturers, customers and end destinations.

This ensures fast shipments to any location, especially during emergency response. It is also close to the International Humanitarian City, a logistics centre for the distribution of humanitarian aid, where major global humanitarian organisations have local offices to quickly respond to global crises.

Aside from a large kit production capacity, the facility is also equipped to stock large numbers of kit components and kits, allowing us to not only respond quickly in the event of an emergency, but also to assemble (non-emergency) custom-made kits for our customers.
